### **The Current Mixed War We're In**

“The first and most essential division of war is that into public war, private war, and mixed war. A public war is that which is waged by him who has lawful authority to wage it; a private war, that which is waged by one who has not the lawful authority; and a mixed war is that which is on one side public, on the other side private (*Hugo Grotius - On the Law of War and Peace*).”

We are currently living through a covert war where law, order and justice have been made to be JUST as cold as ICE in the ultimate con-version reality game that we didn't know we were playing while simultaneously being played.

By definition a mixed war is a war that is fought on one side in the public and the other in private where we have the right to settle problems regardless of whether the usufruct, UNIDROIT, de facto governmental authorities say we do or not. A mixed war has an army against an individual who is destined to either be reincorporated into the corporeal body of the corps(e) orating its Belief Systems (BS) and logos (logic) that incorporated entities must abide by or we will stand up and claim our right to be our real selves without living in contracted states.

### **Not All Statuses Have Standing**

Status and standing are worlds apart from one another, literally, for one is real and the other only appears to be. This is the reason we take 'the stand' when on trial (where the legal beagles TRY-ALL to convict the one accused of an offense) within the legal fiction compared to when we're real and can stand face to face.

Once a conversion of title occurs the status of the one standing for themselves changes and men and women in positions of power, within the corporate context, are then able to move the case or law suit forward despite no firsthand testimony; to have standing means we have the right to speak and be heard in the matter in question. If we don't have firsthand involvement in a matter we can't speak to it unless we've sworn an oath of allegiance to the BAR or Crown corps(e) that grants us authority to 'make believe' we can get involved in matters that we have no business in; the legal system makes private matters public business literally.

Without standing one cannot speak to a legal or lawful matter which is why legal professionals do their best to gain jurisdiction early, by asking the one accused of something if we understand; this is a trick that implies the one who believes they are acknowledging comprehension of the topic in question when they are actually agreeing to 'stand under' the jurisdiction of the one whose question converts us into the 'Accused' or some other status than we originally were. Tricky devils!

Juris means 'of law; of right' whereas diction is what is spoken or wrote which creates a whole rule book or Codex that makes up the juris-diction of any place that consents to the con sent for the consciousness of those in agreement with it. This includes those deemed illiterate and unable to speak or decide for themselves and who thus must be represented by another which is where the conversion in identity expands its reach of power.

*A literate person is described as one who can, with understanding, both read and write a short, simple statement on his or her everyday life. An illiterate person is one who cannot read or write such a simple statement. Notice the mental state in state-ment?*

As living souls alive at this time in our shared story we have various identities based on the self-image we have adopted or crafted for ourselves, by default or design, and every identity comes with an in-built entity in the ID.

### **Identity and Self-Image In The Grand Scheme Of Things**

Identity is the unique set of characteristics that can be used to identify someone in a way that leaves little or no question in their mind about the truth of who they are in this world and where they fit within it. It's based on all the personas we wear around others and identify with, swapping between 'masks' of identity based on the environment we're in and how we want to present ourselves in it.

*Persona: the aspect of someone's character that is presented to or perceived by others; the personality that someone projects or 'plays' in public compared to in their private or personal life can be markedly different.*

Personas are the masks we wear in public and is connected to the person that we've come to believe we are, yet we've lost sight of just how many personas we've taken on as identities that invite (corporate) entities to feed off of us.

Every persona has an identity and every emotion has a personality of its own so when different aspects of us show up as energy in motion that isn't fully integrated it can knock us off if we aren't grounded in the moment. This is why our emotional nature is often used against us by 'the establishment' whose sole focus is on profits instead of the people paying the price. Our emotions are weapons that can be used against babies who don't know how to wield their pen, except with awareness we can change that to protect ourselves.

Your self-image is the image you have of yourself and how you believe people perceive you which may or may not reflect the truth based on your sense of self-worth, esteem, beliefs and INNER security that brings the nervous system connection into moments of insecurity.

Our INNER WEBS matter because they are how we defend against the predators in this interconnected empire we didn't know was still under Roman rule. Corporations have just become the modern-day pirates on commercial seas and if we don't know who and whose we are it's easy to get walked to the plank where we lose our lives to sentences ascribed to us by 'the professionals'.

*Plank (as a principle): an important principle on which the activities of a group, especially a political group, are based.*

### **\$ponsored Surprises**

The element of surprise can be helpful or harmful depending on how it's used but with foresight the 'shock value' lessens and the negative emotional charge dissipates like energy in motion is meant to. Now is our chance to address the shocking truths that have been masquerading as 'conspiracy theories' for as long as the current psychological operation (psyop) has been in play.

It is time to see that \$cience when spelt with a dollar sign is bought and paid for by the founders of the beliefs which generally pay our salary and sponsor the licensing bureau that allows those certified under their banner to legally practice. But that isn't how it's presented to the public on the surface where you're only reading the label about what's in the box. And when you judge a book by its cover you're bound to miss key points.

\$cience that has been sponsored by corporations that create problems just so they can offer the solution. It is a dangerous proposition because bought and paid for Belief Systems become the BS people's sense of safety is based on. It's horrifying to realize that the majority of accredited post-secondary training schools are indoctrination centres that land us firmly in-doctor-nation where we believe the letters behind or before our name change our perceived worth.

This is where we have to consider the fight within that the Cherokee grandfather famously told his grand-one about in the parable about inner conflict and the choice we have to choose life or destruction. It's also the reminder that the devil knows exactly what we want and how to trick us into squandering our energetic resources for its benefit which is why 'idle hands' and bored minds are the devil's playground.

Licenses require we lie to our senses in order to assume someone else's BS (Belief Systems) to be more important than our intuitive feelings.

Where our intuition guides us with our feelings, our mind is full of rations of lies that can be divided out intelligently by the rational mind. Yet when there is a disconnect between the head and heart then the hands get confused and we often step back in hesitation when we're really needing to step forward in faith.

Notice the dollar sign has only one line? That's because it's only backed by our belief in its value rather than something of substance like gold or silver; paper money based in fiat currency isn't worth more than the paper it's printed on until we put our faith in it and trade it amongst ourselves. This is in thanks to the Federal Reserve System that was enacted in 1913 by men and women whose souls paid a heavy price their greed didn't prepare them for.

### **Competing BS & Cognitive Dissonance**

The fight between the faithful and FEARFULL became palpable to me when in an expanded state of awareness that allowed me to tune into the energetic patterns of the signs, symbols and omens showing up along my path in a way I hadn't before. While I realized I was tuning into energetic patterns that others couldn't see the way I could, I hadn't expected my experience to be documented as a 'psychotic episode' that ties directly to the experience of cognitive dissonance.

Cognitive dissonance is an internal battle between the known/familiar and unknown/unfamiliar that brings up uncomfortable emotions we don't know how to process because we've been living in an emotionally repressed society we were led to believe we were free within, but only to a point.

Cognitive dissonance is the result of two competing ideas co-existing in the same space, and when you start to bring about change (even for the better) it will create discomfort because you will no longer think, act or believe the way you did before; that also means those around you (and within you) will have to adapt to the new you and many are content with the status quo.

Status is a position or rank in relation to others and 'quo' is something received or given for something else. This is how the 'status quo' is used against us.

Expansion is what we came here to experience and even if you may not know the way yet, by the time you are through the process of transformation you will have experience to share with others who care to hear your tales which they may learn and grow from too.

That being said, comprehending the reality of the Justinian Deception means you can be better prepared for any interactions you may have with the private quasi foreign corporate shadow government officials that are effectively acting like pirates within a mixed war the majority aren't even aware is in play.

While the Mental Health Act has become the modern age witch-hunt, legalized and normalized, it's time to see our souls can't abide by the lies any longer.

## **The Justinian Deception**

The Justinian Deception was coined by Romley Stewart and Rohan Lorian who put together an in-depth explanation of the current state of corruption we're being subjected to through the use of trickery and dogged language.

Their efforts exposed how the current governmental bodies are part of an underworld, criminal, counterfeit, corrupted corporate world that governs the dead while deceiving us to believe we are the conversions we're assigned because of lies we haven't known how to protect ourselves against.

They revealed how DOG-LATIN and (di)GLOSSA text are used by legal professionals to gloss over corporate impositions we would object to if we noticed them. And also revealed descriptors for the current state of government-control factors that are currently in place within the corporate culture of modern times.

Their efforts uncovered the Mother of all deceptions and how slavery is a thriving business on the global plantation that our present world has become.

While both men are based on the lands known as Australia, their findings apply to all other nation-states on the planet (with slight variations in referenceable legislation) because they all follow a common system or Codex.

## **The Li(n)es Between Lawful & Legal**

Lawful and legal are different but are implied to be synonymous, as part of the hidden grammatical deception that has dragged us into the under-world by counterfeit means we've consented to without being fully informed of the truth.

Something lawful follows the substance of the law, while something legal follows the form of the law. Something can be illegal in its form and not be unlawful in its substance, such as standing up to the mandates of the current de facto powers that are causing harm, loss and fraud against the people and the lands we are meant to be stewards of. This means our actions may be illegal in the letter of the law, but not go against the spirit of the law, and therefore not be unlawful.

'Lawful' carries with it an implication of ethics and morality in a way that the term 'Legal' does not. 'Legal' merely implies that something is allowed while 'Lawful' would imply that something is rightfully allowed.

It's about following 'the spirit of law and justice' instead of 'the letter of the law' which is why I don't believe we need to limit ourselves to what has already been written when we are the ones alive here now to write the scripts others will one

day read, learn from or follow because of the life we choose to lead now and the example it became for others.

### **What is real & what's the difference?**

Existence is what we are all experiencing in our own way, at this particular time that we are alive to (hear or) read these words. Yet existence is not the same as our perception of 'life' and what 'having one' entails.

We are meant to be hue-man beings we've grown to believe yet I'd rather have access to all hues in the moment so that I can be kind like mankind are meant to be, it's just we likewise thought humanity and mankind are referring to the same thing when this is not the case.

This distinction also applies to the difference between the planet and the world, and sex versus gender. To put the differences into perspective, consider that the planet is the place where we live but the world includes both the planet and its people therefore making it a mental construct. Sex is what we do with another and also what we are assigned based on our biology whereas gender is the combination of our biological components and our sexual desires which change depending on how we feel about the one we're interested in.

The recent fixation with race, gender and sexual identity is directly connected to the popularization of and profitability of the mental health system that created the Diagnostic and Statistical Manual of Mental Disorders (DSM) making diagnosis profitable for the corporations that provide services to people who are struggling to find their place in the world. It also means we've become accustomed to letting our behaviour define us, just as we've let our statuses do too.

If we consider the fictitious nature of the corporate world that has become such an apparently normal part of our existence then we begin to see why so many more people are struggling mentally now. The truth is not what it seems and something feels off but it's been too hard to put a finger on it so those who question it either opt out of regular life in functional or dysfunctional ways or we've forced ourselves to look the other way and pretend everything is fine.

Real things are tangible and reflective of what is deemed legitimate, 'set in stone' or somehow definite. Intangible and unreal things combine what is real with concepts that present themselves as legitimate when in truth they are not.

A relevant example in modern(a) times is the recent fixation on identifying ourselves using pronouns; also known as pronomens these are words that can function as a noun phrase, or substitute for a name, that refers either to the participants in the discourse or to someone or something mentioned elsewhere in

the discourse. Discourse refers to “written or spoken communication or debate” about a mental construct that can become an obsessive topic of fixation especially when it becomes paramount to our sense of identity.

For filing purposes within the internal filing cabinet of the subconscious mind, these lived and imagined experiences and interactions get stored together for easier reference by the mind. This makes it more challenging to discern between memories we’ve experienced literally and those we’ve been emotionally moved by if we’re in a confused or suggestible state, especially when we derive so much of our identity from the labels we’ve taken on.

### **Nomen and why no men have a true Cognomen or Pronomen**

What hasn’t been commonly discussed, but needs to be, is the fact that taking on a pronomen creates an additional box of identifiers that can be used to change someone’s identity and become a man or woman with many masks.

What is a literal mask but a disguise worn to amuse or terrify, sometimes in the name of allegedly preventing the inhalation of pollutants and other times to cover visible features? But to then see how our ‘persona’ is the aspect of our character that is presented to or perceived by others, we begin to see that they are the masks we’ve taken on without realizing how impactful they are to our identity.

The pronomen impacts our identity by reflecting the box we check and then feel the need to defend in order to justify our choice to invest our energy into it. This is what makes BS so difficult to challenge without personally offending the one using that identity to feel more safe and secure within themselves.

The cognomen (last name) is similar except it’s an even more sinister and covert deception because surnames have become a cultural standard. It can be seen as the trojan horse we let through the gates of our inner realms unawares.

The cognomen is the surname, last name, legal name, Roman name or title of the family the one in question is traditionally born or traded into through marriage or business which are commercial activities that change our identity and make our cognomen especially valuable to the corps(e) that has laid claim to us; until we make our own claim to remain free and lawfully self-governing as a woman or man in our private capacity at all times, even when moving through the public, we can be more easily manipulated by corporations that profit off of our confusion.

Any professional who tries to knowingly create a joinder between my nomen and cognomen in order to morph my identity as a lawfully self-governing woman into

something else will have to look me in the eye and identify themselves so I can make a claim of harm and fraud against them in their private capacity too.

The eye I see looking back at me is the one I require the full name of so I can lawfully put them on notice, in their private capacity, that their actions cause me harm, loss or fraud and need to stop. Notice is the first step in remedying a crime-in-process; the next is making a common law claim in a court of competent jurisdiction to resolve that which the one playing a role refuses to solve once addressed. Professionals have got accustomed to lack of personal accountability but we, the people of these lands, are now awake to and aware of the fraud.

We are meant to be the conscience of the corps(e) and if we don't act honourably then we are going to lose far more than just our own freedom in this life. For this reason, I believe it is time to take the suits of title, status and personage off so that we can be real and see that we are responsible, accountable and liable for the choices we make and how they impact others.

### **Legal Piracy On Common Lands**

Corporations are the modern-day pirates of the metaphoric waters of Maritime and Admiralty law jurisdiction. They have extended their reach onto the common lands we walk on, using a corrupted legal system designed to maintain their rule covertly and without consequence for the ones operating it.

The majority are becoming unsettled and uneasy with the turning of tides that is underway and the people will pay high karmic consequences for taking another's life in the name of seeking justice through vengeance if we don't rebuild our sense of community before the existing structures crumble to be replaced. Soul ties have real consequences for the light within us and those behind the corporate sector at the highest level know about the energetic component of going against our conscience to cause harm, loss or fraud against another.

Why get involved in another man or woman's war for a paycheck when we know we're expendable pawns in a chess game being played to capture faithful ones?

Corporations are corps(e) that orate their rules and claim uncontested territory whenever they can. And while we didn't expect our cells to be the territory in question, now we're seeing how the quest the question evokes directs our ions.

Our insecurities get targeted because we are creatures of comfort who avoid pain more than we are inclined to seek pleasure so keeping us in a reactive state instead of a creative one neutralizes our power. It also makes us question ourselves and turn outwardly to find answers that we haven't yet unlocked within

ourselves. Corporations then can capitalize on this by elevating our sense of importance in the world based on our positions, titles and designations.

What we have to realize is that pirates used to carry a box of flags in order to put up the one an approaching vessel might trust most easily based on the design, it's just now that the water laws have crept onto the common lands we're living on we must see how the banners, logos, flags and corporate brands are the modern-day equivalent, wrapped in a different package.

It's related to the genres of gender that have become part of our cultural identity too, given how much emphasis has been placed on our anatomy and gender in recent years. That's because there is a transhumanism agenda at play designed to convert all natives into an 'other' status that is owned by the holder of title.

Slavery is still occurring but the levels of it are tied to the varying forms of capitalization, of both words and the statuses we're converted into and then are implied to be.

### **Capitalization, Communism & Caged Constraints Considered**

*"Capitis diminutio" is the diminishing of status through the use of capitalization in Roman law.*

**Capitis deminutio** or **capitis diminutio** (diminished capacity) is a term used in Roman law, referring to the extinguishing, either in whole or in part, of a person's former status and legal capacity based on the capitalizing of names and titles the man or woman identifies with and agrees to.

The greatest diminishment of capacity, *capitis deminutio maxima*, involved the loss of liberty, citizenship, and family (e.g., being made a slave or prisoner of war). This is what those innocent souls caught in the black 'trafficking' market are faced with and the incomprehensible part is that property is considered expendable without consequence for the owner of it when abuse is permitted.

I do believe the Uyghurs and Falun Gong people in China are prime examples of this maximal diminishment of capacity from being free to owned and subject to reprogramming or whatever treatment is assigned to us. Many within the 'freedom movement' here in Canada have grown concerned by the alleged internment camps that have been erected around the country that could have become a comparable experience if we hadn't broken the spell with awareness of who and whose we truly are before our fate was sealed.

The media have been weaponized against us because we've allowed an anonymous hand to call the shots as to what gets attention and what does not; historically controversial stances that challenge the current powers-that-be have been suppressed but now it's all rising to the surface and the tides are turning. The media is where the behind-the-scenes maneuvers often appear as dramatic and exciting details and announcements we interpret literally without realizing the danger zone we're in when blindly trusting and following popular propaganda.

*Capitis deminutio minima* consisted of a person ceasing to belong to a particular family, without loss of liberty or citizenship. This is basically how names and titles are changed that split the storyline of one character into many.

This is the entry level conversion that moves us away from being real and creates a joinder with our last name that has been incorporated as a culturally necessary part of our identity; this is what binds us to the fiction 'under the radar'.

Just like when children play 'dress up' and pretend to be the role they are playing, we have continued playing this game without noticing the significance of the spells cast using our name and titles.

### **The Jurisdiction of LAW(S)**

LAW in its capitalized form stands for Land, Air, Water but does not include Space because that is outside the bounds of limitation; what is unlimited cannot be forced into a contracted state without consent. So when the con is sent for your consciousness and conscience be full of care to tread carefully.

L = Land is where men and women stand on common ground under 'common law' which is the unwritten and unlimited law of conscience and morality, based on not causing harm, loss or fraud to our fellow man. Violations here lead to criminal complaints and charges, just beware there is no capitalizing of letters or hyphenating of words, for 'Common Law' and 'common-law' are both written and therefore limited versions of the original.

A= Air represents ecclesiastical law or 'Canon Law' which is the collection of rules imposed by authority granted power by the people who believe in the author-i-tie my identity to outside of themselves. Canon law refers to the body of ecclesiastical law that developed within Christianity, particularly Roman Catholicism, that governs the internal hierarchy and administration of the church. To say the church and state are separate is a myth intentionally planted in our collective consciousness to uphold the corrupted version of reality that is now changing because it's required.



W = Water represents Maritime and Admiralty law which are used interchangeably to cover a variety of cases including contracts, torts, injuries, and other offenses that take place on any navigable water. The Crown is the equivalent to a pirate ship and we are presumed to be '(in)mates' until we take back our power as the authority of our own lives and claim the right to live in the land of benefits instead of sail the seas of liabilities within the belly of the beast.

The Great Fire of London in 1666 (which started on Pudding Lane in what is now called the 'Square Mile') coincided with the "Cestui Que Vie Act" which declared all persons property of the VASSAL (holder of title) which 'dry docked' a foreign corporate power onto the lands it claimed to overlay.

### **The Titles, Suits & Emperors With No Clothes**

Julius and Caesar were titles given to the man who founded the Justinian Dynasty with the help of his nephew whom he adopted, groomed and made heir to the Roman Empire, its subsidiaries and their equity without the common man or woman knowing what really happened.

It's the tale of an heirless man looking to leave a legacy he could be remembered by through his underdog nephew who came from humble beginnings to become one of the most influential figures of history because he commissioned the writing of it and was forceful about its implementation.

### **The Boxes Our Worlds Become**

Labelism is the incessant need to label those who disagree with you in an effort to vilify one's opponents by assigning them with disparaging labels that would limit them. It is precisely why we have been trained to 'check the box(es)' that define so much about our identity; failure to contest the replacement of what is real with that which is implied leaves us vulnerable and at the mercy of the one whose box we checked without special eyes to see the lies hidden in plain sight that specializations gift us with. The illiterate trip on these lies without knowing what hit them and we've had enough of that already. All ready to know why???

When you step onto a pirate's ship you expect there to be boobytraps set to trip up any trespassers to make them pay before fair warning is officially given or questions are asked. It's just that we never realized the whole corporate model is the equivalent to a fleet of pirate ships in cahoots with one another to swindle and screw the unsuspecting.

It's time to recognize the flags, banners, logos and brands of the corporate realm for what they are and to treat them accordingly without revering them or idolizing their figureheads; idle eyes looking outward rarely turn inward to the guru within.

The sacred texts of this world advise against the worship of false idols but the irony is that the church and state were only ever divided on paper and in our minds. We didn't realize the two halves of Rome (East and West) have been operating in tandem from the margins and sewers of the underworld ever since the alleged fall of the Roman empire, when it only truly fell in the West.

This East versus West division of power is symbolic for the split between church (religion) and state (politics). This is akin to the mind v. body on a personal level.

The aliases, pen names, and identities he took on during his lifetime include but may not be limited to 'Justinian I', 'Justinianus', 'Caesar', 'Augustus', 'Augustus Caesar', 'Flavius', 'Flavius Petrus Sabbatius', 'Petrus Sabbatius Iustinianus' and 'Flavius Petrus Sabbatius Iustinianus' depending on how you stack or unpack and present his many titles and names.

In order to tell Justinian's story however we must tell of how his childless Uncle Justin took him under his metaphoric wing by adopting him, giving him the Roman title 'Justinianus' (cognomen) and bestowed him with the inheritance of the Roman Empire.

Justin himself (AKA Julius Caesar) was said to have been born in 450 in North Macedonia to a Latin speaking province and was mostly illiterate but also a practical military-minded man who scaled the ranks within the armed forces and seized the throne in 518. His Plebeian sister had a baby boy in 483 whom he eventually adopted and named 'Justinian' after his own Roman (house) name.

Justinian received a formal education in the capital of the Roman Empire (Constantinople) where his Uncle Justin held high military command as the count of the Excubitors (composed of units of imperial guards) before using his position to take the throne of the Roman empire in 518.

Justinian was instrumental in helping Justin come into power as his literate chosen heir-apparent and ally who also served as Justin's confidant throughout his reign.

In 525 Justinian was given the title 'Caesar' in honour of Julius Caesar (AKA Justin)'s lineage, which stopped being a familial name around AD 68 when it was adopted as a title by Roman emperors. It seems time was adjusted to correct the ledger and create confusion around who really was who in his-story (history).

Justinian is said to have been functioning as 'virtual regent' long before Justin made him associate emperor on April 1, 527; he assumed full emperor status later that year when his Uncle Justin died and he assumed the title 'Augustus'.

Justinian's Uncle 'Gaius Julius Caesar Octavianus' was often referred to simply as 'Augustus' which became the title all successors to the throne took on as part of the role thereafter. When Justinian received this title in 527 he combined it with the other title he received from his Uncle and became known as 'Augustus Caesar'. Within a matter of years, he founded the Justinian Codex that is still used today.

While the characters, roles and placements have changed the storylines throughout the years, the patterns we play out together have largely stayed the same culturally simply because we have forgot our own power and started giving it away without regard to why we've been given access to so much.

### **The Just In Time ConneXion To Now**

With the help of his corrupted cronies (a close friend or companion) and 'pullers of strings' by corrupted hands, the man known as Justin Pierre James, of the family Trudeau, has been the symbolic scapegoat for the treason that extends far beyond him. ## **Jurisdiction & Territory Battles**

Jurisdiction is an important term to comprehend so that you don't accidentally drop a knee to a corps(e) that corrupts your vessel in unexpected ways when signing on behalf of a corporation that is doing the devil's dirty work while accruing karma for your soul. Devil is lived backwards which is what the fiction has required good men and women to do for as long as we can remember.

Jurisdiction is a conjunctive word that joins 'juris' and 'diction' together. Juris are the rules crafted by one who claims rule over someone or something and dares to speak or write it. Diction is the words and phrases agreed to in spoken or written language. When combined, juris-diction grants power and authority to the uncontested governing body of a place without revealing the contest it truly is.

I believe what people who have failed trying a common law approach to legal dilemmas have done incorrectly is allowing a fictional character to make a false claim without knowing how to stay real. Paying someone else to speak for us doesn't keep us or others safe, especially during times of crisis, which is why it is best to stay present rather than be represented as our person or any other.

### **De Facto versus De Jure Governance**

De facto comes from the Latin phrase "in reality or as a matter of fact" and denotes someone or something that is in fact, or in effect, whether by right or not. This is the status of the present governmental body and I challenge any man or woman to challenge this claim; a corporate entity does not qualify for this challenge for it only appears to be real so does not count. I do not believe anyone protected by a suit should be able to contest a lawful claim of belief without personal liability, accountability and responsibility for standing against me so I hereby put any man or woman on notice of my right to express my beliefs without impediment or trespass.

This is how we face-off the professionals who are masquerading as something other than they truly are on behalf of a corporation they've temporarily derived their identity from; they stand as the bully trying to steal for the corps' benefit.

A de facto government may be in actual possession of authority and control of the state, and therefore be able to call the shots as fiats and mandates but it has no legs to stand on because an entity is a mental construct only. When we're incorporated into the machine we become cogs expected to remain in position despite the ebbs and flows that are a natural part of life. In finance, the World Bank says "a de facto government comes into, or remains in, power by means not provided for in the country's constitution, such as a coup d'état, revolution, usurpation, abrogation or suspension of the constitution. This is how we were incorporated into a fictitious corporate body that was implied to be de jure.

A de jure government rules 'by law' which are beyond the control or regulation of man or his creations. De facto government control political affairs in a state by compartmentalizing and delegating power between incorporated bodies such as service agencies, offices and corporations *whereas* de jure government are said to be the legal and regularly constituted government of a state.

We just weren't considering states, nations and provinces in relation to the mental constructions we form our substance into and around in order to remain (belong) in one particular form or another.



It's time to recognize the fight between form and substance that the world of fiction relies on blurring the lines between so we don't quite remember how we slipped but the metaphoric 'goose egg' on our head from the fall lets us know we were entrapped and fooled somewhere along the line.

What we weren't expecting was how the myths and legends of ancient civilizations would come creeping and seeping up through the dogged, dashed and crooked lines of the sign-at-your-own-risk signature lines we've been taught to 'sign your life away' on. Yet how do we keep Anubis, the keeper of dead bodies in the underworld, from stealing our souls back into contracted states?

### **UNIDROIT, Usufruct Usery of Us**

We look up the next component of the currently corrupted seas we've been sailing on unawares which is UNIDROIT. This is an independent corporate body designed to study needs and methods for modernising and harmonising private and public relations under the cover of commercial law that is used to achieve the desired objectives.

Usufruct is defined as "the right to enjoy the use and advantages of another's property short of the destruction or waste of its substance" that operates according to two different systems that determine levels of ownership.

In a perfect usufruct, the usufructuary is entitled to the use of the property but cannot substantially change it whereas in an imperfect usufruct system, the usufructuary has some ability to modify the property.

It's found in civil-law and mixes jurisdictions to create a joinder between the right to use or enjoy a thing possessed directly without altering it (called usus) and fructus which is the figurative right to derive profit from a thing possessed. Might that put 'by his fruits you shall know them' into perspective under a new light?

It's significant to note that the third civilian property interest is abusus (abuse) which is said to be "the right to alienate the thing possessed, either by consuming or destroying it (e.g., for profit), or by transferring it to someone else (e.g., sale, exchange, gift). Someone enjoying all three rights (usus, fructus, abusus) gets to enjoy full ownership of the property in question. So what is proper to you?

Given the propaganda campaigns during the Certificate Of VEX Identity Death-AI experiment of the COVID-19 pandemic, combined with a transhumanism agenda targeting the consciousness of our youth, it's easy to see the imperfect usufruct system trying to steal power from unsuspecting victims.

The reason this psychopathic and criminal organization has been legalized and normalized as 'just the way things are' is due to an outdated tradition of shutting up and putting up with the cringe-worthy cultural nuances, trends and traditions so many have felt powerless to change.

We need to acknowledge the fact that we were lied to in an effort to get us used to lying to others in the name of being in 'the know' and in on the joke too. The counterfeit deceptive corporate administrative entities passing themselves off as true common law governments of the people is a falsehood that needs to stop.

### **The JOKER**

This is precisely why the joker has been a bigger player in his-story books than we've been taught to believe, in accordance with the MAXIM of LAW "let him who wishes to be deceived, be deceived."

The King James Bible of 1611 is said to be the "Authorized Version" used within the legal realm where those who swear on it submit themselves to being under the jurisdiction of its proclaimed Grantor Of Domain; this GOD is different from

the Grantor Of Dominion that all domains we can lay claim to were created under.

Only the creator of all is able to grant dominion to a man or woman because dominion is charge or command over the territory of a sovereign. If a 'supreme ruler' is sovereign then another cannot be granted the same status without reducing the power of the one titled supreme or most high; could this be why dominion within the virtual realities we invest so much energy into are full of domain names and www.urlds?

The Hierarchy of Creation is a useful way to see the pecking order of Existence with a twisted base.

The Grantor Of Dominion (GOD) is the creator of all energy in existence (1) who created man and woman to be the individuated expressions of the divine incarnate (2). According to Romley and Rohan "Only living man holds the highest authority, being Dominion, over the natural mineral and energy wealth of Eden" (Earth-land).

Men in positions of power (under Justinian's rule) then created the entity known as the VATICAN (3) which claimed 'legal title of Earth' to allegedly confirm man.

The VATICAN became the VASSAL which is a third party 'debtor of man' who passed the buck back to living man by creating the Babylonian system where we stay babies for a long time in the form of a personage or other legal status. This relates back to Capitus Deminutio Minima which is where we're portrayed as minors whose guardians must call the shots for ones too dumb to decide for self.

Our Person (4) is the holder-Trustee-Legal Title Holder of the debtor accounts of the VATICAN that we can either use to live in the land of benefits (as the creditor) or remain in the land of liabilities (as the debtor).

The Ledger/Creditor (5) is the beneficial side of our PERSON where we are able to direct the ones who are meant to manage and move the equity in our trust accounts on our be-half, for the benefit of the one giving the orders. Legislation exists that requires public servants fulfill their public duty when directed by a man or woman who have claimed certain rights without contest; referencing this legislation using 'C.F' or 'compared to' means we are not limiting ourselves to that legislation but are reminding the professional of their requirement to perform.

The Debtor (6) is the one deceived into holding the ledger of the VATICAN; we are implied to be surety for charges placed against our person by any legal organized body that claims to have jurisdiction over registered (state) property.

This is why, in Matthew 22:21 of the BIBLE when a group of Pharisees confronted Jesus using a 'closed question' that would provide a yes or no answer on whether it was lawful to pay taxes to Caesar, the Roman emperor, he asked whose face was engraved on the coins used for payment. When they answered it was Caesar's face, Jesus replied with "Then render unto Caesar the things that are Caesar's; and to God the things that are God's."

### **Key Proponents Exposed**

Pharisees were said to be a member of an ancient Jewish sect, distinguished by strict observance of the traditional and written law, and commonly held to have pretensions to superior sanctity which *is the state or quality of being holy, sacred or saintly (virtuous)*. It is also connected to hypocrisy because the adage "do as I say not as I do" often applies to those who act one way in public but another in private.

Which then leads one to question which Jewish sect these 'Pharisees' followed and how it connects to the word Jew.

A Jew is said to be someone who believes in and practices the religion of Judaism.

Interestingly, in the "early modern period", a 'court Jew', or court factor, was a Jewish banker who handled the finances of, or lent money to, European, mainly German, royalty and nobility (people of title). In return for their services, court Jews gained social privileges, including in some cases being granted noble status.

What if we now saw that those practicing the religion of Judaism have thus been mistakenly placed in the same category as 'court Jews' (bankers) who have been severely persecuted by the mislabeling, especially in the last world war.

That war was a prime example of how labels can be misattributed and used to divide and conquer people who wear the appropriate identifiers. It also reflects the brutality of heartless orders fulfilled by people broken by the weight of their role within the machine.

Ever heard that when World War 2 ended it was the Germans who surrendered, not the Nazis? Well just as not all followers of Judaism are bankers, not all Germans were Nazis either. But there certainly have been many choosing to 'not see' the dangerous ledge we've been led to by people following orders for personal gain.

While the Nuremburg Trials were said to have brought some justice to those who 'went along to get along', Operation Paperclip was a secret military program that redistributed many of these German scientists, engineers and technicians into positions of power within alphabet agencies (FBI, CIA, WEF, WHO, etc) instead of serving the sentences they were given. Identities were changed and rewards were issued to those willing to fulfill evil orders at the expense of those who were terrorized and tortured in the name of stealing all they had to give.

Evil is live backwards and the entities of evil rely on the importance of our sense of personal identity in this world.

### **The Real Guard In Eden**

The Biblical story of the garden of Eden warns of eating the fruit of the 'Tree of Knowledge' which changed Adam and Eve's perception of reality to create blurred boundaries between what is public versus private.

### **DOGGED Language**

DOG-Latin is Latin text based on the grammatical rules of English which make it a debased (criminal, immoral, evil, counterfeit) and a bastardized version of each that is *lower in quality or value than the original form, typically as a result of the addition of new elements*. For this reason, DOG-LATIN is said to be the language of the illiterate because it is an illustrative text instead of a grammatical one.

To make it clear let's look at the following sentences to prove the point:

**“This is proper English descriptive text.”**

Only the beginning of a sentence is capitalized and the first letter of a noun (person, place or specific thing), with proper punctuation to show the completion of a thought (sentence). This sentence follows the 'science' of English grammar.

**“THIS-IS-PROPER-WRITTEN-SIGN-LANGUAGE-USING-THE-GRAMMATICAL-RULES-OF-LATIN-TEXT”** (Identified in Article 11:147 of the Chicago Manual of Styles, SIXTEENTH EDITION).

Due to the capitalizing of multiple letters within each word, the words become signs that get joined together by hyphens and are described as an illustrative sign language.

**“THIS TEXT IS DOG-LATIN BEING LATIN TEXT BASED ON THE GRAMMATICAL RULES OF ENGLISH”**

Without hyphens to connect the signs that each capitalized word is, each word stands alone. To those versed in these covert tactics, the above sentence actually reads this way:

**“THIS.TEXT.IS.DOG.LATIN.BEING.LATIN.TEXT.BASED.ON.THE.GRAMMATICAL.RULES.OF.ENGLISH.”**

One rest (space) in relation to SIGN-LANGUAGE constitutes a stopple between the signs whereas one rest in written English constitutes the joinder (connection) between two words. Two rests are required to confirm the stopple between words appearing in English text, whereas only one rest will cause the stopple between words appearing as SIGNS.

A stopple is something that closes an aperture which is a hole or an opening through which light travels, that being the information contained in the sentence in this instance.

There is no jurisdiction between two separate languages appearing on one document which is why the blame is placed on the one who is deemed illiterate by not seeing the dogged language on the page. “English” and “Latin” or “DOG-LATIN” do not follow the same rules which means they do not exist in or operate under the same jurisdiction.

When an alien or foreign text appears on legal documents, the problem is passed onto the one who reads it literally and misinterprets the text. This is when a lien can be placed against the man or woman who unknowingly consented to a joinder between what is real and what is not; a lien can only be placed against our person which is the interface used by the corps(e) to deal with us who are real in a covert conversion we don't see until we have eyes to see the lies.

*Lien: a charge or encumbrance upon property for the satisfaction of a debt or other duty that is created by agreement of the parties or especially by operation of law.*

While a party of one is not generally considered a party, I present this passage this way to say any conversion of the original into something other than we are moves us away from the truth we are all subject to so that we become subjects of another's truth.

In Latin ‘ab-‘ means “away; from” so when natives, for example, accepted the status of aboriginal they were incorporated into a legal fiction they became identified with. This identity became all-consuming of rights that were then converted into privileges, benefits, debts, duties and liabilities super-imposed onto the real man or woman they believed was done for their benefit.

## Just Gloss Over The Truth

**‘Glossa viperina est quae corrodit viscera textus’** means ‘it is a poisonous gloss which corrupts the essence of the text.’

Gloss: To conceal or disguise (something unfavourable) by treating it briefly or representing it misleadingly.

The all uppercase GLOSSA text of DOG-LATIN is in disguise, appearing to be written in English when in fact it is a sign language that converts each word into a sign that stands alone unless connected by a hyphen.

Diglossia is referred to as the serpent’s tongue or ‘two tongues’ because it mixes two varieties of the same language in a sentence which corrupts the whole thing. This is the written form of mixing jurisdiction given each language follows different grammatical rules so it is unclear which has command of the sentence.

The all UPPER CASE lettering used within the legal system is a prime example of the serpent’s tongue in action as a sentence may appear to be English but without hyphens to join the signs the capitalizing converts each word into, the words are no longer connected and each word stands alone as if it were a sign. Latin is a proper written sign-based text that uses symbols, caricatures and signs that are connected by hyphens that string together a sentence. Without them a capitalized sentence is non-sensical gibberish (unintelligible and meaningless).

## The Sentences We Are Offered

Within the legal system men and women acting in positions of power are able to pass judgements against others as a professional duty that comes with real life consequences for the one who receives the life (or death) sentence issued. Without comprehending the power of our words, how they’re spelt, or paired together they (words) can become a s-word that is used to harm us.

While syntax is about the arrangement of words and phrases to create well-formed sentences that follow proper English grammar rules, it deals specifically with the order of words in a sentence. Once we understand the syntax of the language then we can get into the semantics of the words themselves which refer to meanings we attribute to the words in a sentence.

Semantics is how one’s lexicon (the vocabulary of a person, language, or branch of knowledge), grammatical structure, tone, and other elements of a sentence

coalesce (come together to form one mass or whole) to communicate its meaning.

Specialists in law have to article for a period following graduation to ensure they comprehend the English language and all the spells at play within the text before they are able to practice law on their own. This is to ensure they are able to adequately defend the fictitious realm they are representing. If they fail to prepare well and come against an opponent who has also prepared well, and versed themselves in the spells words cast, it could jeopardize the whole system.

Just as in secret societies that ‘black ball’ members if one existing member within the organization is not fond of the one who desires to get in, students of law can be denied licensing if their skill level is not up to par. This threat of ‘not being good enough’ keeps the committed professional so focused on their own practice that taking on the bigger beast has not been possible without high personal consequence.
